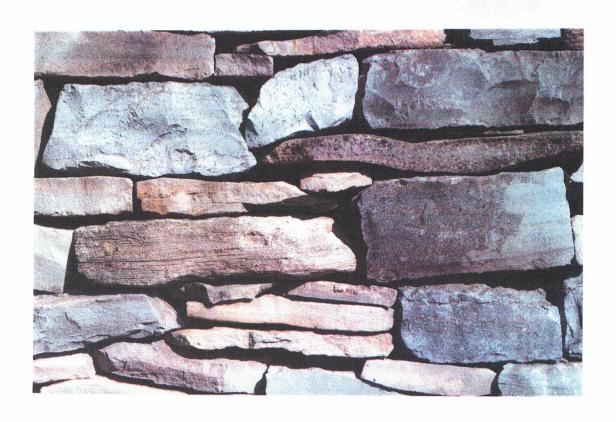

Rector & Lead Pastor's Report to Vestry 2025

"For no one can lay any foundation other than the one already laid, which is Jesus Christ." (1 Corinthians 3:11)

As we gather for our Annual Vestry Meeting, it is fitting that we reflect on our foundation as a faith community. The Apostle Paul reminds us in the above verse from his first letter to the Corinthians that Jesus Christ is the only true foundation upon which we can build our lives and ministry. This truth is particularly significant in times of change, challenge, and uncertainty. In a world marked by economic instability, geopolitical tensions, and the impact of international policies—such as the ongoing struggles between our country and the United States over tariffs and trade—it's easy to feel unsettled. Yet, as believers, we find our security not in the shifting circumstances of politics and economics but in the unchanging foundation of Christ. A strong foundation in Him ensures that we remain steadfast in faith, committed in service, and hopeful in vision. As we look back on the past year and prepare for the future, I want us to consider four key aspects of strengthening our foundation in Christ—as individuals and as a church community.

1. Deepening Our Faith Through Worship and the Word.

A strong foundation requires a commitment to deepening our faith through regular worship and engagement with Scripture. When we invest in deepening our faith, we are better prepared to navigate life's uncertainties with courage and conviction. As members of the Body of Christ, we're called to strengthen our relationships with one another through love, encouragement, and service. Living Waters Financial Position at the end of 2024

Living Waters has two accounts, both with TD, which have all our liquid assets, a current account and an investment account. The amounts in these accounts are shown in the table below. The bank balance is corrected to include outstanding debits from 2024, which includes things like our rent for the Senior Centre and seeral uncashed cheques. It also needs to be corrected for our December PAG, which didn't arrive until Jan 2. After correction the account balance is \$65,266.92. The balance in our investment account is as of Jan 11 because I was away at the end of December and account doesn't have a history. This amount is likely to be a very close approximation to the true amount as of Dec 31 and represents a 13% increase over last year.

In addition, we have a few pieces of equipment (including computers) that constitute our non-liquid assets. These cannot be easily turned into a set amount of cash, but are estimated to be worth approximately \$3,000.

Our liquid assets are divided into a number of funds, totaling \$32,991.35 as shown in the table below. The remaining \$57,372.96 is in our operating fund. Of the funds below, all but one are internally restricted meaning that they were designated by Parish Council and it could re-assign them. As of Jan 1, the Grace Fund was topped back up to \$5,000 using money from the Operating fund. As this occurred after Dec 31, the increase is not shown below.
